LETTER FROM THE EDITOR

My grandson, Dresden, recently started preschool. I have been helping transport him to school. He is autistic and has to go to a special school. It is about 30 to 40 minutes away depending on traffic. When I retired it was very important to me to help with this. Last year my son and his wife were considering a local school but they felt it was not the right place for Dresden. They were able to get a grant and started doing a lot of at home and outpatient therapy. He also had to get tubes in his ears. At the time all of us weren't sure if these were the right choices. We visited other preschools but a lot of them would not accept autistic children. Dresden was accepted into his current school and he is exceling in the program. The grant money is paying the tuition. Tom and I were taking a walk in the woods this evening and we both agreed it was the right thing to do to wait for this school. When I pick Dresden up from school he is singing and laughing. It took me along time to get promoted at work but I now see I had to wait for the promotion that was right for me to be created. The other promotions I applied for were not suited to me. My last supervisor said he prayerfully created that job for me. It was my favorite job of my working career. All of this reminds me everything is in God's timing. "But they that wait upon the Lord shall renew their strength; they shall mount up with wings as eagles; they shall run, and not be weary; and they shall walk, and not faint". This verse promises that those who hope in and trust in God will receive renewed strength, allowing them to rise above challenges with power, as eagles do. (Isaiah 40:31) To everything there is a season, and a time for every purpose under heaven. (Ecclesiastes 3:1)

MJM Board of Directors Nominations

It's time to nominate members in good standing to serve on the MJM Board of Directors.

Nominations must be received in writing by Amber Beckman, B.O.D. Chairman, by October 1, 2025. You can email the member/s name/s and a brief explanation why you believe they should serve on the Board of Directors to Amber Beckman at 614-598-0682 or email it to Amber at amber_beckman@hotmail.com. Please speak to the person(s) you are considering nominating to be sure they are in agreement to serve on the MJM Board. Members may not nominate themselves. Posted from MJM’s Handbook on the qualifications for Board Members.

Motorcyclists for Jesus Ministries will be governed by a Board of Directors. All corporate powers shall be exercised by or under the direction of the Board of Directors.

The Board of Directors will be current riders whose experience, expertise, and wisdom are essential to the Motorcyclist for Jesus Ministries. Nominations for the Board of Directors will be made in writing by any member, other than the nominee, to bring his or her name before the Board for

consideration to be put before the general membership for a vote. All nominations should be in the hands of the Chairperson of the Board of Directors no later than October 1. This deadline will be published in the August and September issues of the T.E.A.M VOICE Newsletter. The nominee must have been a member in good standing with MJM for a minimum of two (2) years. The member making the nomination shall include a brief biography and reasons why he or she believes the nominee would be a good board member. The Board of Directors shall then approve, or disapprove the nomination. Nominations will be considered with regard to geographical location. If approved by the Board, ballots for the nominee(s) shall be mailed individually to each member to approve their choice of nominees.

Elected Directors may serve for two (2) consecutive three (3) year terms. However, they must be elected by the membership for each of those terms. Director may appoint a member to fill a Board position resulting from an individual not meeting attendance requirements, resignation, or death. The appointee will hold office until the next election of the Board of Directors. Completing a vacated term does not count as the first of two (2) consecutive terms. Decisions of the Board will be determined by a simple majority vote.

The Board of Directors shall consist of at least four (4) elected members, but not more than seven (7) plus the Chaplain/Educational Director. The Chaplain/Educational Director will be an ex-officio member of the Board. He or she will also be involved in the administrative functions of the Ministry. A Chairperson of the Board will be elected annually by the Board of Directors. The Chairperson of the Board may vote only to break a tie.

The Board of Directors, each being born-again, loyal Christians, will focus attention to all Motorcyclists for Jesus Ministries programs and activities, to assure that all programs and activities reflect a loyalty to the gospel of Jesus Christ, and that all programs and activities will have an evangelistic outreach to lead motorcyclists to a saving knowledge of Jesus Christ and to a true worship experience. The Board of Directors will establish governing policies, appoint and approve the Chaplain/Educational Director, Officers and Road Representatives, and prescribe activity guidelines.

All officers and Road Representatives, with the exception of the Board of Directors, will be reappointed annually for the ensuing year upon review and approval by the Board of Directors.

The Board of Directors will hold a minimum of two (2) meetings per year. The time, place, and means of such meetings will be determined by the Board of Directors. A Director may be represented by proxy at only one (1) meeting per Fiscal year April 1st through March 31st, unless a valid reason acceptable to the Board was in evidence. If a Director misses two (2) Board meetings without a prior valid excuse that would be accepted by the Board, he/she would be removed from the Board of Directors. Absent Directors would keep attending Board members from having a quorum and thus unable to have a legal meeting. Decisions on special issues may be made by use of Fax, E-Mail, or telephone through polling each Director. To constitute a quorum, meeting would require that two-thirds (2/3) of the total Board of Directors be present.

A majority vote of the Board is required to remove an officer or Board member, when it has been determined and documented that the individual in question has not conducted themselves or

represented the ministry of the “Motorcyclists for Jesus Ministries” according to the guidelines as presented in the most recent Membership Handbook. Prior to the vote, the individual whose conduct is in question must be contacted by the Chairperson and be given the opportunity to speak directly to the Board Members at a meeting of the Board. An opportunity for MJM members to speak on the individual’s behalf or support the individual’s position to the Board shall be provided. The Board is to consult with all MJM Officers with knowledge of the events surrounding the conduct in question and consider their input as a final decision is made by a majority vote of the Board.

The Board of Directors may remove from the membership rolls any MJM member for misconduct. A hearing will be granted to that member by the Board of Directors to determine final judgement.

If a member wants to speak at a Directors’ meeting, he/she must notify the Chairperson in writing to be put on the agenda no less than one week prior to the meeting. The guest member will be allotted five (5) minutes to present his/her topic.

Directors will donate their time and shall not receive a salary for their services as Board members or officers of this ministry.

Three-fourth (3/4) of the total Board of Directors must be present to change, rewrite, or cancel any part of this handbook.

The Board of Directors will examine all nominations and make the selection during the Fall Board of Directors Meeting. The person, couple or T.E.A.M. will be honored at the next MJM Spring Kick-Off.
